Dr. Marshall Chasin



Dr. Marshall Chasin is a distinguished audiologist with a career focused on the prevention of hearing loss among musicians and performing artists. He is the Director of Clinical Research at the Musicians' Clinics of Canada, which he co-founded with Dr. John Chong in the mid-1980s. He also holds academic appointments at the University of Toronto and Western University. Dr. Chasin earned a B.Sc. in pure mathematics and linguistics from the University of Toronto, a M.Sc. in Audiology and Speech Sciences from the University of British Columbia, and a Doctor of Audiology (AuD) from the Arizona School of Health Sciences.

He has authored over 200 articles, eight books, including *Music and Hearing Aids* (2022), *Musicians*, and *the Prevention of Hearing Loss*. He writes the "Back to Basics" column in *Hearing Review* and the weekly blog *Hear the Music* on HearingHealthMatters.org.

He served as Editor-in-Chief of the *Canadian Hearing Report* for nearly two decades and now leads *CanadianAudiologist.ca*. He is also the Editor-in-Chief of the upcoming *Handbook of Clinical Audiology* (2027 edition).

Dr. Chasin's contributions have been recognized with multiple awards, including honors from SAC and OSLA, the Queen Elizabeth II Diamond Jubilee Medal, and the Canada 150 Medal. He also developed the *Temporary Hearing Loss Test* app.

A black belt in Karate and Kung Fu, Dr. Chasin claims to be undefeated against five-year-olds—though the seven-year-olds are another story.
